#### Highway

Bridge NY has started. This is to build a bridge on the Bailey Road over the Independence River. There will be a check coming from Bridge NY Grant, as reimbursement for this project, that will need to be sent to Lewis County as well as adding in the Town's share of \$3,525.00 for this project.

Checking on accessibility of getting a new Pickup truck for the highway garage again on November 15. Will also have to check/compare pricing.

CHIPS – Reimbursement for the first round has been submitted and should receive payment in December 2022.

Virkler Tree Service has been hired to do more tree trimming on town roads.

#### Water

Re-levy Report for the water accounts for the Town of Watson have been submitted to Lewis County Tax Department on 11/8/2022 by Michelle Ward and signed by Jeff Hoch.

Temperature probe for the storage tank is being replaced to prevent freezing.

Flushing of hydrants was discussed by the board members and the concerns that were voiced by the citizens that called the office were also discussed. Possible suggestion/solutions are to coordinate with a billing cycle and add it to the wording on the bill or to do it at night.

Also looking into doing a flow rate test.

#### New Business

Watson Town Park - New park rules/regulations and cost were discussed. Application for use was given to all board members for review. This will be discussed at the next meeting and finalized. After accepted by the Town Board it will be posted on the website.

Postage Machine – Looking into an alternative solution for this, postage paid envelope or stamps and envelopes. After a decision is made to cancel lease with current company for postage machine.

First Aid- Looking for alternative solution for this, will look into purchasing an eye wash station for the highway and first aid boxes for the highway and the office. After decision is made will cancel services through Unifirst –First Aid.

Justice Donald Regetz has submitted his JCAP Grant paperwork to the town and to JCAP.

DEC- Vicki Roy stated that a letter should be written and submitted to the DEC in regards to last month's meeting with reference to the concerns of the horses and horse people using the public roads and public waters and other concerns voiced. She stated that she will write said letter and submit it to the board for approval before sending.
